1. The engagement is purely on consolidated basis and shall remain in force for the period of one year only and subsequent drawl of honorarium shall be subject to verification of date of birth/ academic and technical certificates/experience/ diploma certificates which shall be got verified by the concerned DDO from the concerned institution. In case of adverse report regarding authenticity of documents, the engagement shall be cancelled straight forward.
2. The performance of the appointee shall be reviewed after every year.
3. In case the appointee wants to quit the service, he/she shall have to inform the department before one month.
4. He/she shall have to work at the place against which he/she has been engaged and shall not be engaged for transfer from the place of posting in any case.
5. He/she shall be terminated at any time for non-performance, indiscipline, absentee from duty or any other reason without any prior notice.
6. He/she shall have to submit an affidavit duly signed by 1<sup>st</sup> Class Magistrate that he/she shall not claim for any regularization of his/her service in the Department/Government.
7. He/she shall not be entitled to any allowances or monetary benefit whatsoever except as admissible under the scheme.
8. He/she shall report in the office of the concerned Chief Medical Officer along with all original documents / testimonials for their duties within a week's time from the publication of this notice, failing which the engagement order will be treated as cancelled without any prior notice and consequently the waiting list shall be operated.
